You can see pictures from the NC Oral Health Collaborative meeting in Kernersville, NC in May. NCDHA was well represented! Thank you to all who participated.




STRATEGIC PLAN

- 3. Expand the future of dental hygiene in North Carolina to strengthen collaborative partnerships.



ADHA's nationwide constituent and component restructuring plan is in motion! This plan is necessary to ensure that all constituents and components are in compliance with the bylaws of ADHA. The first major step was the signing of our Charter Agreement with ADHA on February 1, 2016. The goal of the Charter Agreements is to ensure that ADHA and its constituents and components work together to meet the needs of current and future members in transforming the profession of dental hygiene. These agreements further ensure that all entities of ADHA are legally compliant, create continuity and quality of member experience and unify the collective brand of ADHA across the country. Together, we are leading the transformation of the dental hygiene profession to improve the public's oral and overall health! #Upward!

As part of our alliance with ADHA, we now have a new name and logo! Our name now represents who we are, an association that represents dental hygienists who practice dental hygiene in North Carolina. We are now the North Carolina Dental Hygienists' Association. We are currently in the process of updating everything associated with our association to reflect the name change as well as our new logo. This change also applies to all the components. All components must also use the new name and logo and

ADHA President, Jill Rethman, recently submitted written testimony to the House Appropriations Subcommittee on Labor, Health and Human Services, Educated and Related Agencies for the FY 2017 Appropriations for the Department of Health and Human Services Impacting Oral Health. ADHA requested that the block on funding for oral health workforce demonstrations grants be lifted, that \$2 million be appropriated and that the following report language be included in the FY 2017 HHS funding bill:

"The nation continues to confront an oral health access crisis, which will not be ameliorated without better utilization of existing dental providers. The Committee urges a stakeholder meeting be convened in order to determine how best to create new entry points into the oral health care delivery system for rural and other underserved populations, better utilization of existing dental personnel and exploration of new types of dental providers."



The Oral Health America's mission is to change lives by connecting communities with resources to drive access to care, increase health literacy and advocate for policies that improve overall health through better oral health for all Americans, especially those most vulnerable. The OHA recently released, A State of Decay Vol. III, which is a state-by-state report of the oral health of the country's 65+ population and the success or failure of states to address those needs. The annual HYPAC challenge is underway! You can help advance your profession by donating to ADHA's HYPAC through ADHA's annual session in Pittsburgh. The Hygiene's Political Action Committee (HYPAC) is a group of dental hygienists and citizens that participate in the political process for federal elected officials who support oral health care of the people that dental hygienists serve. HYPAC is the ONLY federal bipartisan political action committee that represents the dental hygiene community by helping elect pro-hygiene candidates for congressional office. The Commission on Dental Accreditation (CODA) directed that the proposed Standard 3-6 of the Accreditation Standards for Dental Hygiene Education Programs be distributed to the communities of interest for review and comment for consideration at the summer 2016 commissions meeting. Comments will also be accepted at a Hearing on Standards at ADHA's annual session. ADHA supports and agrees with the Dental Hygiene Review Committee's recommendation for this revision to the standard. It is critical to dental hygiene education that faculty to student ratios are sufficient to ensure the development of clinical competence. ADHA further supports the proposed revision of faculty to student ratios for preclinical, clinical and radiographic clinical and laboratory sessions from 1:6,; to not be less than one faculty for every five students.


